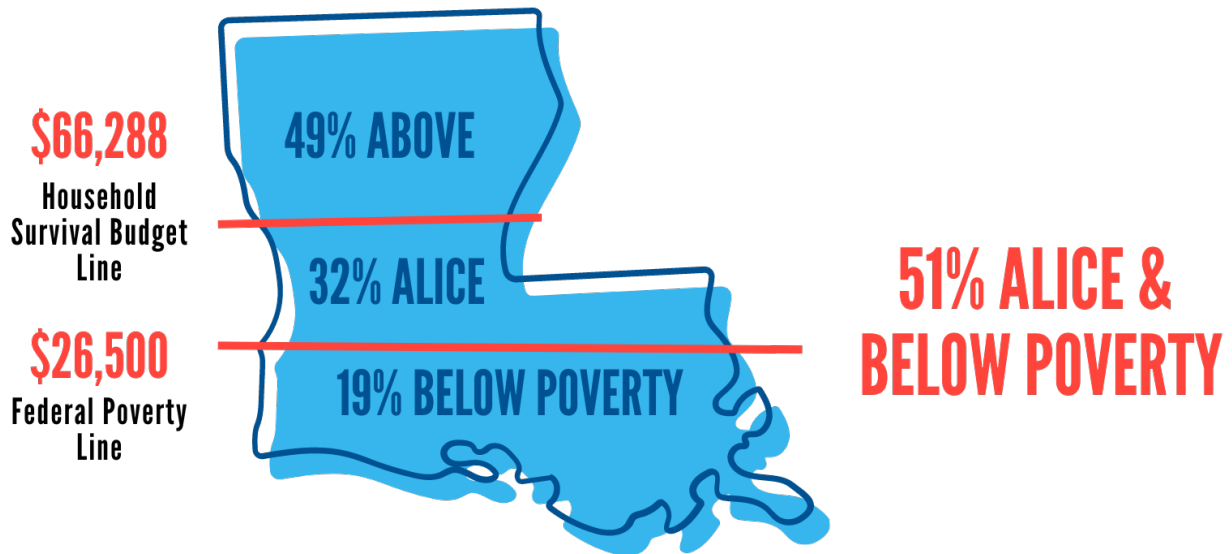

# WHO WE HELP

## who is ALICE?

CAUW's work prioritizes the **ALICE population**. **ALICE stands for Asset Limited, Income Constrained, Employed**. The ALICE population is comprised of working residents that are struggling to make ends meet, have little to no savings, and are one emergency away from falling into poverty. The ALICE population includes every race, age, gender, and ethnicity and work in a variety of professions across our community.

To provide a better understanding of ALICE, the **2023 United Way ALICE Report for Louisiana** reveals that **32 percent, or 562,552, of Louisiana households are ALICE and another 19 percent live in poverty. Together, 51 percent of all Louisiana households cannot afford basic expenses** – housing, child care, food, transportation, health care, cell phone access, and taxes. From 2019 and 2021, 22,980 additional households in Louisiana found themselves struggling financially, despite tax credits and other pandemic and Federal Emergency Management benefits.

# HOW WE'VE HELPED

## programs & initiatives

### BANK ON BATON ROUGE

Bank On Baton Rouge is an Economic Mobility initiative that serves three focus areas:

- Assisting underserved populations with second chance bank accounts
  - Promoting financial literacy education
  - Exploring FinTech (Financial Technology) programs for the Greater Baton Rouge area
- This year, **190 people** participated in financial webinars, **20 clients** were served through financial coaching and over **1,000 people** were informed through community outreach.

### SINGLECARE PRESCRIPTION DISCOUNT CARDS

SingleCare partners with pharmacies nationwide to provide customers with a lower price on prescriptions.

- This year, CAUW helped serve **2,975 people** with an overall savings of **\$268,976.07**.

### UNITED4VETS

United4Vets aims to coordinate, streamline, and provide wrap-around services to veterans and their families.

- This year, we were able to provide work-ready events to **over 50 veterans** in our 10-Parish service region and **13 companies** were engaged and connected to our veterans.

### UNITED WE FEED

United We Feed is a Basic Needs Initiative that leverages corporate and community partnerships to provide fresh food access to our community's ALICE and poverty populations.

- This year, CAUW helped provide **950 boxes** of fresh produce to over **17,100 individuals**.

### VOLUNTEER INCOME TAX ASSISTANCE PROGRAM (VITA)

The IRS's Volunteer Income Tax Assistance (VITA) program offers free basic tax return preparation to individuals who earn \$60k or less annually.

- This year **6,249 tax returns** were completed via VITA volunteers and MyFreeTaxes bringing **\$7,669,336 dollars** back into the community.

### UNITED WAY 211/CAUW

United Way 211/CAUW is a free confidential service that helps people find the local resources they need, 24 hours a day, seven days a week.

## CARE COORDINATION

NEW

In the past year, more than 27,296 people have reached out to United Way 211/CAUW to receive information, referrals, and navigation help. Continuing this tradition of connecting help seekers to service providers, we expanded our reach into referral and care coordination. Our coordinators follow a closed-loop system meaning that referrals aren't just made, they're followed up and the outcome of the referral is tracked. Our coordinators seek all available avenues for our clients, ensuring that their needs are met. Since its inception, we have provided care coordination services for 499 clients.

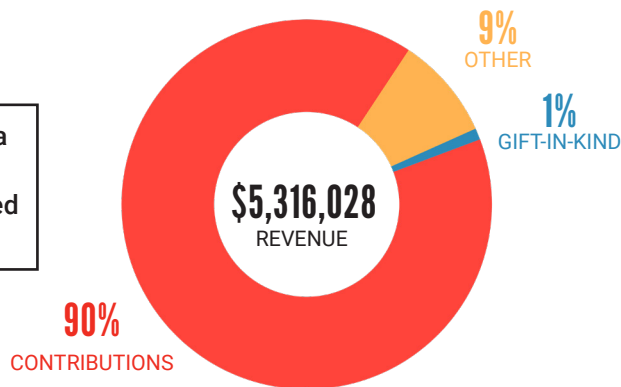

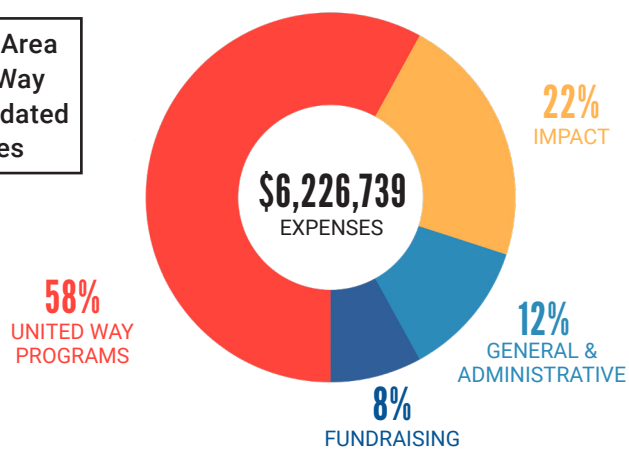

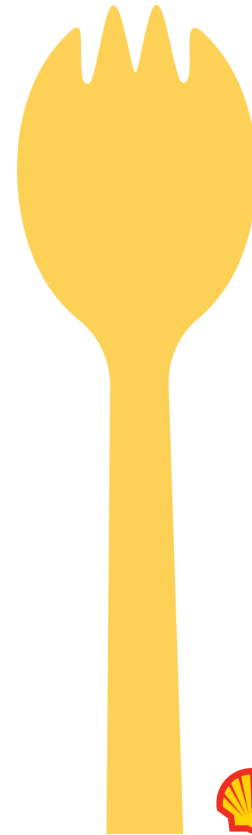
